### FIREWORKS.

Everyone should be able to enjoy fireworks safely, whether at an organised display or in the back garden.

### Fireworks and the law!!!

Fireworks can be used in the UK anytime from 7am to 11pm.....

### Exceptions are:

Bonfire night: 7am to midnight

New Year's Eve, Diwali and Chinese New Year: 7am to 1am the following day

You **MUST NOT** set off or throw fireworks in the street or other public places as this is a **CRIMINAL OFFENCE**.

### Buying Fireworks

You can only buy fireworks (including Sparklers) from a registered seller for private use on these dates:

15 October to 10 November

26 December to 31 December

3 Days before Diwali and Chinese New Year.

### Where they can be used

If you buy fireworks for your personal use, you are only allowed to use them on your private property or property where you have been given consent from the landowner.

**You can be fined up to £5,000 and imprisoned for up to 6 months for selling or using fireworks illegally. You could also get an on-the-spot fine of £90**

### Safer outside School

Bridgnorth Safer Neighbourhood Team are visiting schools at either drop off time or pick up time to ensure that children are arriving at school and leaving at the end of the day in a safe manner. We ask that adults that are collecting children from school park sensibly and legally. Please **NEVER** park/pull-up or even stop on the zig-zag lines. They are there to keep pedestrians safe.
